Conclusive Proceeding

I, as the returning officer of the Tennis Ball Cricket Federation of India for the Election for the term 2024-2028, which took place at Hotel Vivek, Bank Road, Gorakhpur (U.P.) on the 11th of February, 2024 at 11:30 am, oversaw the nomination process for all positions. All candidates filled out the required nomination form (Form-2) between the 29th and 31st of January, 2024. I received all completed nomination forms within the specified time frame and thoroughly examined each form (Form-3 & 4) for accuracy. Subsequently, between the 2nd and 3rd of February, 2024, candidates had the opportunity to withdraw their names from consideration. No candidates withdrew, resulting in only one candidate running for the position of President, five candidates for the five Vice President positions, one candidate for the Secretary General position, one candidate for the Treasurer position, five candidates for the five Joint Secretary positions, and five candidates for the five Executive Member positions. 
